Emissions reduction targets

Crowndale Foodservice Ltd commits to reduce absolute scopes 1 and 2 GHG emissions by 42% by 2029 from a 2024 base year. With regards to our scope 3 emissions, the majority of our suppliers are national or global companies with their own Carbon Reduction Plans in place. Our scope 3 emissions for purchased goods and services should reduce in line with

these plans.

Carbon Reduction Projects

To meet our sustainability targets we have identified key projects that will enable us to reduce our emissions.

Scope 1

We are exploring alternative fuel options and all new company cars will be hybrid or electric.

It is our intention to install electric vehicle (EV) charging points so that we can electrify our vehicle fleet. This will work alongside our current delivery routing software to minimise emissions further.

Scope 2

We are looking at installing solar panels to provide renewable energy.

Scope 3

We have introduced a Cycle to Work scheme and we plan to build bike shelters to encourage our employees to use this scheme. We also encourage the use of car sharing and public transport when possible.

We are considering a 4 day working week and offering the opportunity for flexible working. We are also encouraging virtual meetings rather than face-to-face.
